2017 – 2018* data compiled by Oregon Department of Education, always 2 years prior

The Oregon English Language Learner Report is an annual publication required by ORS 327.016, which reports on financial information for English language learner programs and the objectives and needs of students eligible for and enrolled in an English language learner program. The report provides information on the demographics of students in English language learner programs in each school district. In addition, this report provides a tool that makes data on English language learners accessible to researchers, media, students, and parents.

In most sections of this report, measures are presented for current and former English Language Learners (ELL). Current ELLs are students who qualified for English language services during the 2017-2018 school year. Former ELLs are students who did not qualified in a prior year.

In accordance with ORS 327.016, the report must be provided to each school district board each year and made available at the school district's main office and on the school district's website.

In order to maintain student privacy, any cell size less than six (6) has been suppressed. Districts with values that have been suppressed are not included in the comparisons. These suppressed values are represented by an asterisk (*).
